Title VI Complaint Form

Title VI of the Civil Rights Act of 1964 and related statutes (42 U.S.C. Section 2000d) prohibit discrimination on the basis of race, sex, color, national origin and creed in programs and activities receiving Federal financial assistance. These procedures apply to discrimination by Eppley Airfield employees, contractors, concessionaires, lessees, or tenants of the Authority, or at Authority facilities. They cover any program or activity administered by the Authority. Specifically, no person in the United States shall, on the ground of **race, sex, color, national origin** or **creed** may be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance. This form should be used to file a complaint if you believe the Omaha Airport Authority has not provided adequate access to services, programs, opportunities or activities. It may also be used to file a complaint if you are a Limited English Proficient Individual and believe that the Omaha Airport Authority did not provide adequate language assistance with respect to a service, benefit or encounter. Título VI de la Ley de Derechos Civiles de 1964 y estatutos relacionados (42 U.S.C. Estos procedimientos aplican a discriminación de empleados de Eppley Airfield, contratistas, concesionarios, arrendatarios, o inquilinos de la Autoridad, o en instalaciones de la Autoridad.
