BY THE COMMISSION:

### O P I N I O N   A N D   F I N D I N G S

The Nebraska Public Service Commission ("Commission"), on its own motion, seeks to investigate the implementation of a proposed ground transportation fee to be assessed by the Omaha Airport Authority ("OAA"), Omaha, Nebraska. The OAA has exclusive jurisdiction and control over Eppley Airfield under the Cities Airport Authorities Act.<sup>1</sup> The proposed fee would be assessed to Commission certificated and permitted regulated motor carriers doing business at Eppley Airfield that provide commercial ground transportation for passengers to and from Eppley Airfield.

The question before the Commission is not whether OAA has the ability to assess such a fee, but instead to determine the appropriate method of treatment for this fee between the regulated motor carrier and the passenger. This fee would affect the published rates for the regulated passenger carriers and the taxicab flat rate system applied toward trips between Eppley Airfield and Omaha area hotels and motels. The Commission therefore opens this docket to explore how carriers should handle the OAA fee.

The Commission finds that regulated passenger carriers and interested parties should have an opportunity to discuss possible options with the Commission and ask OAA representatives questions regarding the fee implementation. Therefore, a public workshop in this matter, hosted by OAA, will be held at 1:30 p.m. on Monday, October 5, 2020 at Eppley Airfield Conference


